## 9. <u>NEW BUSINESS</u>

a. Targeted Acquisition Assistance Program (TAAP) Request from EN-RICH-MENT Parcel #s: 202882, 228091, 216343, 217227, 234985

Peters stated that RPC staff recently received requests from EN-RICH-MENT (Betty Smith) which is a non-profit organization. They are interested in acquiring some properties in the area of 10<sup>th</sup> and 11<sup>th</sup> Streets NW between McKinley and Shorb Avenues NW to expand and utilize as an arts garden, and they also have plans to build an Arts Preparatory Academy Campus to further their mission. Copies of support letters from the City of Canton were provided for the Board. Staff has reviewed their request. Amy Armour was present representing EN-RICH-MENT. Creighton asked if the plans were to construct a building on the parcels. Armour stated yes, and the original intent was to request parcels just for additional community gardens, but they have since been able to plan a funding campaign enabling them to move forward in building a performance arts campus that can better facilitate the mission of the program. Arnold asked if there was any engagement between their organization and the school nearby. Armour stated many of their students do come as referrals from the school and live in the neighborhood. They also have music instructors from the Canton City Schools. Creighton moved, Arnold seconded, and the motion carried to approve the acquisition request from EN-RICH-MENT.

### 10. OLD BUSINESS

a. Property Management Software Update

Peters stated some additional staff have been given access to the system so they can enter in information. Cuyahoga County is working with RPC staff to implement some additional features that they have created that staff will be able to utilize with the system. They are reorganizing a few sections based upon comments from users. The Board members will be receiving their log-ins in the near future.
