2. ROLL CALL – Board Members Present

5. <u>UPDATE FROM HABITAT FOR HUMANITY</u> – Aaron Brown & Allison Harvey

Aaron Brown and Allison Harvey from Habitat for Humanity gave a presentation on how Habitat's partnership with the Land Bank has increased their opportunity to put strategies together to make a greater impact on neighborhoods. The Renewal Project works within a targeted area to create a better quality of life for residents within that neighborhood. Habitat does new construction, home preservation, critical home repairs, demolition, and repurposing land for green space. The Land Bank's Targeted Acquisition Assistance Program (TAAP) has assisted Habitat in acquiring tax-delinquent, vacant lots and homes in Canton and Massillon, which has proved very useful in increasing the potential in making an impact in those neighborhoods. Statistics and examples were given showing the impact the Land Bank's programs have made within those targeted areas.
