- a. Targeted Acquisition Program Requests
 - Iron Workers Local 550 (Parcel 208032)

Peters stated the Iron Workers Local 550 is a nonprofit organization named 618 High Avenue Corporation who is asking the Land Bank's assistance in acquiring this tax delinquent, vacant lot where the back of this requested parcel does touch their property. Creighton moved and Smith seconded to approve the targeted acquisition request as submitted by Iron Workers Local 550. Roll call vote: Zumbar - yes, Smith - yes, Creighton – yes, Green – Yes, Arnold - Yes. Motion carried.

8. OLD BUSINESS

a. BishopsGate Update

Nau gave an update on the BishopsGate property. The property is currently being cleaned up by the USEPA with a \$500,000 grant. He requested the Board grant him permission to accept the property from the forfeited lands list when it becomes available. They envisioned the Land Bank taking title to the property and then partnering with Lake Township with a 50/50 demo, and after this property is given a clean bill of health from the EPA, then the property would be disposed of in some way. If there are some revenues coming from it, then they could split it with the township. But all he was asking permission from today was to be authorized to accept it from the Auditor's forfeited lands list. Creighton moved and Smith seconded to authorize Nau to accept the BishopsGate property when it becomes available on the Auditor's forfeited lands list. Roll call vote: Zumbar - yes, Smith - yes, Creighton – yes, Arnold - yes. Motion carried.
