7. UPDATE FROM HABITAT FOR HUMANITY EAST CENTRAL OHIO

Beth Lechner, Executive Director gave a presentation on Habitat for Humanity of East Central Ohio. Habitat has completed fifty-one projects with the Land Bank to date. Over the past thirty-five years, they have built 642 houses and 91% of the funds they raise go directly to the building program. Habitat East Central Ohio is number twenty-six of the 1,200 Habitat affiliates in the United States.

In order to sign on with Habitat for Humanity, families must first qualify financially. They need to show a two-year consistent work history and fall between 30-80 percent of the median income. The families take classes that teach them how to assist in building and maintaining their homes. There's a six-week financial success course that every family takes. A new interpersonal development class was added six years ago called Foundations. The last class before the families move into their homes is an estate planning course.

With each home comes a garden shed equipped with a lawnmower and weed-whacker that the families are trained to use. These homeowners get a zero percent interest mortgage. A Habitat home is

a three-bedroom, 1,200 square foot house with a basement. It costs approximately \$115,000 to build. It costs \$50,000 to sponsor a Habitat home.

Habitat not only builds homes but also buys the land and sometimes buys houses to either rehab or demolish. If they get a lot that is not big enough for a home, they can turn it into a "pocket park" which is maintained by Habitat. By partnering with the Land Bank, Habitat has been able to acquire 125 parcels and complete fifty-one projects. Forty-one of those are new construction houses, four preserve-a-homes, three demolitions, and three park installations. Forty-four percent of the new Habitat builds have been done in the last few years using these properties acquired through the Land Bank. Habitat has engaged with 135 subcontractors and invested 5. 1 million on land bank projects.

Peters presented the TAAP application. The first is a request from the city of Alliance to acquire a tax delinquent vacant lot on East Summit Street.

• Habitat for Humanity – 16 parcels

Peters presented the TAAP applications submitted by Habitat for Humanity. They are requesting to acquire 16 parcels for new construction.
