Bob Nau stated the Canton Township School is demolished and the project 95% complete. This project was funded by the Land Bank and Canton Township. It was a replacement project in the Fiscal Year 22 Demolition and Site Revitalization grant. The project will be reimbursed by DOD at 75% with a 25% match. The match was split between the township and the Land Bank.
