



Vacant Lot Program Application

The purpose of the Stark County Land Reutilization Corporation's (SCLRC) Vacant Lot Program is to turn tax delinquent, vacant and abandoned lots into well maintained, tax producing properties by making these properties available to qualified applicants.

Basic Eligibility Requirements

Please closely review the requirements below and check the boxes indicating that your application meets all requirements.

Please note: If all boxes cannot be checked, applicant is not eligible to participate in the Vacant Lot Program.

Key Considerations

1. This form is a statement of request only. The SCLRC does not commit to transfer the property.
2. Please submit only the application at this time; do not submit a deposit fee.
3. Please allow 60 days for your application to be reviewed.
4. If your application is approved, you will be required to sign a memorandum of understanding/purchase agreement, and will be required to pay a deposit before the SCLRC begins legal proceedings to obtain the property.
5. While land banking allows for an expedited land transfer process, the foreclosure proceedings to obtain the property could take 1 year or longer to complete.
